








## Rules about taking away people's liberty

Some new rules about taking away people's liberty have been put into the Mental Capacity Act. The Government is asking people what they think about these at the moment.



# What the words mean

## **Court of Protection**

The new court which deals with everything to do with the Mental Capacity Act. The court decides what is best for people who cannot decide for themselves.

## **Lasting Power of Attorney**

A power a person can give to another person to make decisions for them about certain things in the future. A person can only do this if they understand what it means. They can also put limits on the power they give to their Attorney.

## **OPG - Office of the Public Guardian**

This is a new office set up under the Mental Capacity Act. It will:

- help the Court by looking after the paperwork and applications for Lasting Powers of Attorney and Deputies
- keep an eye on Deputies to make sure they are doing their job properly
- work with the police and social services when they think that somebody may have been abused.
